



WILDLIFE DAMAGE AND NUISANCE CONTROL APPLICATION AND PERMIT

By authority of Part 401 of Act 451, P. A. of 1994, as amended, an approved permit is required for all Wildlife Damage and Nuisance Control Commercial Operators. Failure to comply with the provisions of this Act is a violation of State law and may result in the revocation of this permit, fine, and/or imprisonment. See Permit regulations in Information Circular Number 9152.

This is not a valid permit until approved and signed by the Michigan DNR Director's authorized representative.

Permittee hereby covenants and agrees to indemnify and save harmless, the State of Michigan, its departments, officers, employees and agents, from any and all claims and demands, for all loss, injury, death or damage, that any person or entity may have or make, in any manner, arising out of any occurrence related to (1) issuance of this permit; (2) the activities authorized by this permit; and (3) the use or occupancy of the premises which are the subject of this permit by the Permittee, its employees, contractors, or its authorized representatives.

To the best of my knowledge, the information supplied by me is true and correct. I understand that this permit does not provide any authorization to circumvent any federal, state, local zoning, or any other local laws and ordinances. I certify that I am not ineligible by state law, court order, or administrative ruling to secure or possess a hunting, trapping or fur dealer's license.
